

## ANNEX I

### REGULATION SPANISH COURSE AS A FOREIGN LANGUAGE IN COLOMBIA FOR EAST ASIAN COUNTRIES MEMBERS OF FEALAC

#### 1. COMMITMENTS OF THE GOVERNMENT OF COLOMBIA

- 1.1 Provide round trip air ticket in economy class from the capital of the home country to the Colombian city where the course will take place. The Colombian Government will be responsible for assigning the placement city.
- 1.2 Monthly stipend of one million six hundred (1.600.000) Colombian pesos for the beneficiary in order to cover basic living expenses, such as accommodation, local transport, and the cost of meals in Colombia. The monthly stipend will be proportional to the numbers of days of their stay in Colombia, and will be paid once per month in arrears subject to the assistance to the Spanish lessons by the beneficiary. It will be checked through report, which will be submitted by the University to the Colombian authorities.
- 1.3 Tuition scholarship for the Spanish as a foreign language course.
- 1.4 International Health Insurance, whose coverage is presented as **Annex III** to the call.
- 1.5 Courtesy Visa during the progress of the course, which be granted for a time of three (3) months and renovated in Colombia before its expiry date.

#### 2. OBLIGATIONS OF THE SCHOLARS

- 2.1 Participate in the training activities before their arrival to Colombia, these activities will be organized by the Colombian Government with the support of the Colombian Embassies in those countries;
- 2.2 Comply with the current laws in the Republic of Colombia and in particular with migratory conditions;
- 2.3 Accept and comply with the Academic and Disciplinary Regulations of the host University.
- 2.4 Take the “Spanish as a foreign language” course at the host University in Colombia.
- 2.5 Fulfill the minimum requirements of the Spanish course, this is, 70% of the highest score.
- 2.6 Attend at least to 85% of the learning hours, fulfill the assignments and exams required by the host University, which is required to approve the course and keep the scholarship benefits.
- 2.7 Participate in the different activities organized by the Colombian Government and participant Universities, including attending to the opening and closing ceremonies of ELE FEALAC.

- 2.8 Keep a clear and direct communication line with the coordinator of the program designated by the Colombian Government and with the contact person at the host university.
- 2.9 Do not bring relatives or companions.
- 2.10 Pay for any additional expenditure during the period of the scholarship that is not included in the benefits.
- 2.11 Be in Colombia during the period of the scholarship and go back to the home country when the scholarship is over. In case of default, the scholar must report by letter and he/she shall relieve the Colombian Government of any duty derived from his/her stay in Colombia.
- 2.12 Accept that the benefits of the scholarship apply only in Colombia and that in case of early departure before the completion of the scholarship; the Government of Colombia reserves the right to suspend any benefits immediately. In any case, the scholar must report any new situation by letter and he/she shall relieve to the Colombian Government of any additional trip expenditure.
- 2.13 Accept that if the scholar does not comply with any of the duties described in these rules of procedure (except in cases of *force majeure* as defined by the laws of the Republic of Colombia) he/she must reimburse the Colombian Government for all the benefits received from the beginning of the scholarship.

### 3. SUSPENSION OR TERMINATION

The Government of the Colombian Republic reserves the right to terminate the scholarship and withdraw its support any time, if any of the following situations occur:

- 3.1 Non-compliance of the stipulated regulations of the initiative submitted in **Annex I**.
- 3.2 Checking by entities related to the initiative of the inaccuracy of the data provided by the fellow in the selection process.
- 3.3 Being excluded from the Colombia University according to the rules of the institution.
- 3.4 For reasons of serious illness or mental disability.
- 3.5 Constitute a violation of any type of Colombia Republic laws.
